This committee does not accept contributions from Lobbyists or Lobbying Firms registered in the City of Los Angeles and contractors bidding on City Contracts of \$100,000 or more requiring City Council or Controller approval. Contributions must be made from donors' own funds and may not be reimbursed by any other person. Contributions from foreign nationals are prohibited.
